* **Residents of Period A** (also current residents) are required to stay in their original hostel places on 26 May, and **perform check-in and check-out procedures on 27 May for moving to the new room of Summer Residence.**

** **Residents who are offered Period C MUST move to other floor at period C due to the need for hostel cleaning**

*** **Residents who are offered Period C and Hostel Places for 2021/22** are required to **perform check-in and checkout procedures on 31 August for moving to the places assigned for term time.**

Successful applicants (**Appendix 1**) should log in their CUSIS accounts to check the bill (the hostel fee and deposit HK\$500) from 17 May 2021 (Monday). **Deadline for bill payment is 26 May 2021 (Wednesday)**, paid hostel fees will not be refunded. **Students MUST keep the receipt and submit to the counter of hostel during check-in.** Failure to settle the bill before the deadline would be deemed as giving up the hostel place offered.

If the successful applicants would like to **give up the hostel places or certain residence periods assigned, they are required to email to the hostel staff by 17 May** (email: shaw-student-hostel@cuhk.edu.hk), so that the amendment of records/hostel fees and reallocation of hostel places can be made in time;

All summer residents are required to observe the hostel regulations. Allotted hostel places are not transferable or changeable. Shaw College Student Hostel Management Committee reserves the right of final decision on hostel place allocation.
